On the Doubly Stochastic Matrix Completion Problem

A doubly stochastic matrix is a square matrix where the sum of each row or column entries is 1. We explore the problem of reconstructing a doubly stochastic matrix using projections-based algorithms, commonly used to tackle feasibility problems.
