*Robust representations of risk measures on Orlicz spaces via Orlicz hearts*

In 2002, Delbaen proved a robust representation theorem for risk measures on  $L^\infty$  via  $L^1$ . It has since been an intriguing problem to extend this result to a more general class of underlying spaces. In this talk, we present a solution to this problem for Orlicz spaces.
